## Election and swearing in of the new officers:

#### **President:**

Ms. Luderitz called for nominations for the office of President. On behalf of the Nominating Committee, Ms. Butler nominated Suzanne Kosempel. The nomination was seconded by Ms. Semper. There were no further nominations, and the Trustees voted unanimously to elect Ms. Kosempel to the office of President.

#### **Vice-President:**

Ms. Luderitz called for nominations for Secretary. On behalf of the Nominating Committee, Ms. Butler nominated Lisa Butler for the position of Secretary. The nomination was seconded by Ms. Mayer. There being no further nominations from the floor, Ms. Butler was elected unanimously.
